### **Main Application**

Riblene GM 20 R is suitable for coating applications where a low neck-in is required. Moreover, for its rheological properties, Riblene GM 20 R can be used for injection moulded high thickness articles, caps, closures, stoppers and houseware.

#### **Processing notes**

Riblene GM 20 R is easily processed in extrusion coating lines. The suggested temperature is 260÷330°C. Riblene GM 20 R can be extruded at thickness lower than 15 µm.

#### Storage and Handling

Riblene GM 20 R is supplied in pellet form. This material may readily be conveyed and bulk fed through equipment designed for conventional pelletised polyethylene resin, provided the equipment is designed to prevent accumulation of the fines and dust particles that are contained in all polyethylene resins. These fines and dust particles can, under certain conditions, pose an explosion hazard. We recommend that the conveying system used be equipped with filters of adequate size, operated and maintained in such a manner to ensure that no leaks develop and earthed adequately. We further recommend that good housekeeping should be practised throughout your facility.

The product should be stored in dry conditions at temperatures below 50°C and protected from sunlight. Improper storage can initiate degradation which results in odour generation, colour changes and can have negative effects on the physical properties of the product.

Before using this product it is recommended to read and understand the relevant Safety Data Sheet.
